BUSINESS MANAGER'S REPORT

To all members of Local 890,

To all members of Local 890, as I've said in the past, Local 890 would only publish a newsletter when there was news worthy of publishing. That is the case with this newsletter. There are currently a few events coming up in the near future that each and every one of you need to know about. First and foremost, the upcoming elections for officers of Local 890. The coordination of the upcoming election shall be the same with nominations in May and an election in June. The process we will use shall be the same as the elections held in 2020 when Covid-19 prevented us from meeting in person to nominate members, or even cast a ballot for members. We did nominations by email or mail, and we voted for the new officers strictly by mail. The increase in participation was so great that a new by-law was proposed and adopted that all elections would be held this way to give more people an opportunity to vote. The BIG change in the election process this time around is that it will be the first time in the last six election cycles, or 18 years, that I will not be on the ballot. It's time for some of you younger members to get involved and lead this great Local Union into the future.

We also have proposed increases coming to Health and Welfare. We were asked as trustees to recently take a vote on some increases, I voted no because there was only one option and that was to increase the cost to you the members. There were no other options as far as changes to the plan that could possibly save members money or reduce the increase proposed. I still believe that there could be value with us joining our statewide health and welfare plan with the National Family Medical Care Plan. Many of the parameters and players within the National Family Medical Care Plan are the same; they use Blue Cross and they also use Save RX. The network would be the same also. The only downside is there would be changes to how much we could save in the dollar bank but what we couldn't save would go back to the check. The main difference is that they have in excess of 110,000 participants. So, if we take our roughly 5,000 participants and add it to theirs it should be better for all of us. I just think that it's a worthwhile option to get a quote and compare rather to just propose throwing money at the problem like we have in the past.

There are also some events coming up that will help educate members on how to use the WEEBF website, things like how to use the site when it comes to filing EOBs or stuff like that or simply just checking your work hours reported. There will also be an online meeting about our retirement plan and some of the features like moving funds around. You will find more info concerning these events later in this newsletter. Also, there will be an event called Health Gauge. This event will be right here at the Local 890 hall and members will be in and out in a short time. The purpose of this is to check a person's blood for illnesses that don't physically show up until it is almost to late. They can detect and predict illnesses just by taking and testing a sample of your blood. We will keep you informed so that all can participate in this event to possibly prevent a bad health crisis.

The 2 dates for the State Retirement Plan are April 13^{th} and May 8^{th} , 2023 - start time 5:00 pm – This seminar would start with Empower followed by a PIMCO Representative and lastly, Duane and Bonnie to address the Plan rules, early and normal retirement, 1x distributions, death benefits, 401(k) etc... We expect this to also be at least $1\frac{1}{2}$ hours -2 hours.

Health Gauge Health Fair

Health Gauge has been chosen by The Wisconsin Electrical Employees Health and Welfare Plan to coordinate our 2023 health fair. Health Gauge has provided mobile health screening services for over 20 years. Since they have started working with Union Health and Welfare plans, H.G. understands our commitment and the importance of health and safety for our members and their families. Health Gauge's health fair includes identifying chronic diseases and preventing unforeseen illnesses to protect our members and their families. Not only does this save lives and keep unions strong, it also helps keep health cost down and puts more money in the member's pocket.

Services include:

Stroke/Carotid Artery Screening

Abdominal Aortic Aneurysm (AAA)

Peripheral Arterial Disease (ABI)

Biometric Screening and bloodwork

Prostate Specific Antigen - PSA (Men 40+)

Thyroid Stimulating Hormone - TSH (Female 18+)

Health Gauge will be reaching out to you directly with information on a date for your screening. Be on the lookout for early summer. We look forward to partnering with Health Gauge to coordinate the 2023 health fair!

OFFICIAL NOTICE OF NOMINATIONS AND ELECTIONS FOR IBEW LOCAL UNION 890

The election will be conducted by mail.

The nominations for officers of Local 890 shall be conducted by email or in-person at the May 4th Union Meeting, and nominations shall be accepted via email until 4:00 pm on May 4, 2023. Nominations shall be sent to the following mailing email address:

Electionjudge@ibew890.org

You may nominate yourself for any office or for convention delegate. After the close of nominations any member nominated for an office, will be contacted by the Election Judge and at that time must provide a written or emailed statement indicating willingness to accept the nomination. No member may be a candidate for more than one office.

Anyone nominated to more than one office must choose the office for which they will be a candidate.

Nominations will proceed in the order of offices as listed in the IBEW Constitution whose term of office shall be 3 years:

President Vice President

Recording Secretary Treasurer

Business Manager/ Financial Secretary/Delegate to the International Convention Executive Board (6 positions)

Examining Board (3 positions)

Additionally, nominations will be held for 1 delegate to the International Convention.

The Business Manager shall be a candidate for convention delegate contingent with the office as stated in Article VIII, Section 3 of the local union bylaws. This leaves 1 delegate position open to nominations for the at-large election. No member nominated for office of Business Manager may be nominated for the at-large delegate position.

To qualify to be nominated, a member must have a minimum of 2 years of continuous good standing in Local Union 890. Good standing means that the member is current in their payment of dues and has been for the 2 years preceding the nominations. Per the Local Union Bylaws, Article III, Section 8 (e) no apprentice shall be eligible to hold office in the Local Union.

An election judge and tellers have been appointed by the Local 890 President. None of these may be a candidate for any office.

The election shall be conducted by mail ballot, and ballots shall be counted beginning at 8:00 am on June 1, 2023. All members in good standing shall be mailed a ballot not less than fifteen (15) days prior to the above-specified date. Ballots received after the close of business on May 31, 2023 will not be counted.

In you do not receive a ballot in the mail by May 22, 2023 please contact the election judge immediately at

electionjudge@ibew890.org and request a replacement ballot.

In the event a run-off election is required, same shall be held on June 22, 2023. The same rules shall apply to the run-off election as were applicable to the regular election. Members who requested an absentee ballot for the regular election will automatically receive same for the run-off.

All officers shall be installed and begin their 3-year terms at the regular meeting of the local union on July 6, 2023.

Candidates shall be entitled to an observer at the polling place and during the counting of the ballots. Observers may not interfere with the orderly procedure of the election. There shall be no campaigning inside the building at the polling place. Signs and literature are also forbidden.

Any member who believes a protest of the election is warranted must present their protest to the election judge prior to the certification of the election results. Further, protests of the election may be filed in writing with the International Vice President of the district within 30 days following the election.

The decision of the International Vice President shall conclude the processing of a protest within the IBEW.

In the event the protesting member is not satisfied with the decision of the International Vice President the member may submit his/her protest to the U.S. Department of Labor.

Organizer Report

Dear Brothers and Sisters,

It's been a busy start to the year for our organizing team. We have conducted over 40 job site visits and met with many non-union electricians in our local. Our team continues to utilize the new wage calculator QR code to show potential members what they are missing out on. Our paystub flyers have been a success and we have received positive feedback from leaving them at the homes of non-union electricians.. We continue to make top-down visits with our local non-union shops to educate them on the benefits of membership.

We continue to pound the pavement and have knocked on over 100 doors in our local alone. Through our work with sister locals, we have knocked on 432 doors in WI so far this year. Our local has added over 40 members since July of 2022. It averages out to just over one member per week. We have already exceeded the I.O. benchmark of a 4% increase in membership for the year. But we are not done yet. With the upcoming work in our local we will need more manpower to fill calls and help our contractors bid work, so don't forget about our organizing incentive when talking with potential members!
